

The “Morning After”

June 22, 2010

Monday, June 21, 2010 the River Ridge Board of Education held a special hearing at 6:50 pm in regards to Section 24-2 of the School Code renewal application for requesting an attendance waiver for Casimir Pulaski’s birthday for the years 2011-2012 through 2016-2017. Board Members David Howard, Barb Schaible, Don Altfillisch, Raymie Diestelmeier and Matt Wild answered roll call. Members Merri Sevey and G. Allen Crist were absent. Also present: Superintendent Brad Albrecht, Principal Pete Scarano, Principal Mike Foltz and representatives from the RREA. No action was taken during this hearing.

Monday, June 21, 2010, President David Howard called the regular meeting of the River Ridge Community Unit School District #210 Board of Education to order at 7:00 pm. Board Members David Howard, Barb Schaible, G. Allen Crist, Don Altfillisch, Raymie Diestelmeier, Merri Sevey and Matt Wild answered roll call. Also present: Superintendent Brad Albrecht, Principal Pete Scarano, Principal Mike Foltz and representatives from the RREA.

Approved the regular and executive session board meeting minutes of May 17, 2010 and destruction of audio executive session minutes from November 17, 2008.

Reviewed the Treasurer’s Report, Investment Report and Activity Reports. Approved bills and payroll in the amount of \$623,393.18.

AVC representative, Raymie Diestelmeier, reported on the June 7, 2010 Jo Daviess Carroll Area Vocational Center minutes. The construction trades project house contract was approved. River Ridge “Outstanding Students of the 2009-2010 Year” were Kiresten Bauer and Tori Ertmer. Joyce McCready was employed for the 2010-2011 school year as Director.

The Board approved the application renewal of the attendance waiver for Casimir Pulaski’s birthday for the years 2011-2012 through 2016-2017.

Supt. Albrecht discussed Board Policy 4:60 in regards to capitalization policy following ISBE Standard currently in place.

The Board entered into executive session to consider information regarding appointment, employment, compensation of employees of the District, report on student information and collective bargaining and took the following action after executive session.

Approved the River Ridge Education Association bargaining agreement as presented. Three year contract with one year salary schedule 2.8% increase and 25% health insurance difference between family and single coverage. The Board voted - Howard, Schaible, Crist, Sevey and Wild aye, Altfillisch nay and Diestelmeier abstained.

Approved 3% salary increase for non-certified staff and 2.8% for Principal Mike Foltz and Supt. Brad Albrecht. The Board voted seven yes.

Approved the employment of Renee Gapinski as instrumental instructor for the 2010-2011 school year.

Approved the employment of Ari Johnson as pre school teacher for the 2010-2011 school year.
