

# The Morning After

August 18, 2009

Monday, August 17, 2009, President David Howard called the regular meeting of the River Ridge Community Unit School District #210 Board of Education to order at 7:01 PM. Board Members David Howard, Barb Schaible, Raymie Diestelmeier and Merri Sevey answered roll call. Members Allen Crist and Matt Wild entered the meeting at 7:02 PM. Also present: Member Don Altfillisch was absent. Superintendent Brad Albrecht, Principal Pete Scarano and Principal Mike Foltz and members of the River Ridge faculty.

The Board took the following action:
