July 20, 2010

Monday, July 19, 2010, President David Howard called the regular meeting of the River Ridge Community Unit School District #210 Board of Education to order at 7:00 PM. Board Members David Howard, Barb Schaible, G. Allen Crist, Don Altfillisch, Raymie Diestelmeier, Merri Sevey and Matt Wild answered roll call. Also present: Superintendent Brad Albrecht and Principal Mike Foltz.

Approved the regular and executive session board meeting minutes and Pulaski public hearing minutes of June 21, 2010 and destruction of audio executive session minutes from December 15, 2008.

Approved and authorized payment of \$506,054.84 for bills and payroll.

Member Altfillisch presented the Jo Daviess Carroll Area Vocational Center July 6, 2010 board minutes.

Approved for release Executive Session Minutes from January 19, 2010 to June 21, 2010.

Accepted the Property Tax Abatement Resolution for the City of Freeport/Stephenson County Enterprise Zone pursuant to the Illinois Enterprise Zone Act. 20 ILCS 655/I et seq.

Accepted the following bids for the 2010-2011 school year as presented:
